Dear Parent/Carers,

The use of web based educational resources has risen steadily over the last decade and is increasingly being used by teachers across Queensland to improve student learning outcomes. As a result the Department of Education and Training requires that parents and carers of all students who wish to have access to these programs **MUST** sign the attached consent form and return it to the classroom teacher. Once the form is returned and if relevant fees are paid (**Literacy Planet and Mathletics**) your child will have full access to these programs at school. This consent form covers a family.

Our school and teachers make decisions about the best technology to meet the needs of our students. Sometimes it is beneficial for students to utilise services provided by third party web based providers.

Ashmore State School utilises third party web based service provider/s listed below to aid students learning. For your student to use the service the teacher will need to register them as a user. Registering with these providers requires student personal information to be disclosed to the provider of the service.
